## TO ENTER ANY SOQPA DESIGNATED CLASS:

Pony must be registered with the  
NQPA, and both the rider and  
owner must be members of the  
NQPA and the SOQPA or OQPA.  
To qualify for NQPA registration,  
ponies must be 46-58" and can  
be measured & registered at the  
show.

"Youth" pertains to exhibitors 18 yrs. and under as of 1/1/20 [born in 2001 or later]. Showmanship may be in English or Western tack & attire. \*Lead Line exhibitors may not enter any other RIDING class at this show. \*\*Generation Horsemanship judges the horsemanship of a team of two riders whose age difference is over 13 years as they take turns showing one horse.

**CLASS FEES:** Exhibition Runs - \$5.00 Regular Classes \$6.00 - Ribbons \$100.00 Classes - \$10.00

[ \$100 classes having less than 12 entries will be paid back at 80% of total entry fees received for that class.]

Grounds/Administrative Fee - \$6.00 per horse. ALL DAY FEE FOR SOQPA MEMBERS: \$55 Per Rider/Equine team, for regular SOQPA and Open classes only; does not include \$100 classes, exhibition classes, nor grounds/administrative fees.

**No refunds on classes scratched by exhibitor. Only classes cancelled by SOQPA will be refunded.**
