"Youth" pertains to exhibitors 18 yrs. and under as of 1/1/19 [born in 2000 or later]. **Showmanship may be in English or Western tack & attire.** **Generation Horsemanship judges the horsemanship of a team of two riders whose age difference is over 13 years as they take turns showing ONE horse.

CLASS FEES: Exhibition Runs - \$2.00 Regular Classes \$5.00 - Ribbons \$100.00 Classes - \$10.00; 80% payback if less than 12 entries per money classes

Grounds/Administrative Fee - \$5.00 per horse. ALL DAY FEE FOR SOQPA MEMBERS: \$45 Per Rider/Equine team, for regular SOQPA and open classes. Does not include \$100 classes & exhibition classes, nor grounds/administrative fees.

No refunds on classes scratched by exhibitor. Only classes cancelled by SOQPA will be refunded.
